RULES FOR USE OF THE NON-GUARDED POOL

SWIM AT YOUR OWN RISK - NO LIFEGUARDS ON DUTY

Dear Waterview Estates Owner:

In order to provide additional usage of the pool facility to the owners, beginning this year, the Association has approved having the facility open during off-season for exercise use by adults, over the age of 18. Children are not permitted anywhere in the enclosed pool area. Since there will be NO LIFE GUARDS ON DUTY during this time, the following requirements must be met in order to utilize the facility and to have your key fob activated:

- You must be a resident in good standing and/or a guest of a resident member in good standing;
- You must acknowledge receipt and understanding of all pool rules listed on the back of this letter and sign the waiver on page 4;
- You must submit the signed waiver (page 4) and access tag registration form (page 3) to CastleCare Community Management via email, fax or US mail (see below for contact information). Each access tag will allow access to the pool during the pool's hours of operation. Additional tags can be purchased for \$20.00 each. Please enclose payment for additional tags with your signed waiver. Payments for additional tags are to be made payable to *Waterview Estates*.

The following schedule will be in place for the non-guarded swim season. Your access tag will only allow access during the days and times listed below. All access attempts are logged. If you are delinquent on your assessments, your access tag will NOT activate the gate release.

Tuesday – Friday 5am to 9pm and Saturday - Open 8am to 9pm All Mondays – CLOSED for cleaning

SWIM AT YOUR OWN RISK - NO LIFEGUARDS ON DUTY

- Swim at your own risk is available for use by adults, 18 years of age and older ONLY.
- Children are not permitted to be anywhere in the enclosed pool area.
- Members must be in good standing with the Association to utilize the facility.
- The pool is open to be used for exercise and not recreational activity, parties, etc. during the non-guarded season.
- No food or drink is permitted in the pool area.
- Restroom access is not available when guards are not present.
- Should misuse of the facility occur by any individual, non-guarded use of the facility will be terminated.
- Executed waiver for key fob activation must be on file with the Association.
