Article 3, Section 4 of the Amended Declaration of Covenants, Conditions and Restrictions for "Waterview Estates", filed of record in the official Public Records of Real Property of Fort Bend County, Texas under Clerk's File No. 2004133762 (the "Declaration") provides:

<u>Section 3.4 Advertisement and Garage Sales.</u> The Board of Directors of the Association shall have the right to prohibit or to make rules and regulations governing and limiting the advertisement and holding of garage sales.

The Board of Directors wishes to standardize the policies and procedures related to the advertisement and holding of garage sales.

GARAGE SALE GUIDELINES

- 1. The Association holds two Community Garage Sales per calendar year for the purpose of allowing homeowners the opportunity to hold a garage sale.
- 2. Any Garage Sale held outside of the regularly scheduled community garage sales, must receive prior approval from the Board of Directors.
- 3. Advertisement of garage sales held outside of the scheduled community garage sales must be requested and approved by the Board of Directors.
- 4. No signage or advertisements should be fastened to traffic signs, mailboxes or other posts within the community.
- 5. Any signage used for an approved sale, must be removed immediately after the sale ends, and may be installed for no more than 24 hours.
